- Install, mount, configure, and commission the display.
- Provide all required accessories, cables, and mounting hardware.
- Integrate with existing AV/IT infrastructure.
- Conduct testing, demonstration, and handover.
- Provide OEM-backed onsite warranty support.
- Provide training to USCL staff.

- Bidder must not be blacklisted.
- PAN, GSTIN, statutory documents required.
- Signed technical compliance sheet required.
- Required local service centre of OEM

- Hard copies will not be accepted.
- EMD must be paid online.

- Bidders must submit all required documents in readable scanned format.
- Non-responsive bids will be rejected.
